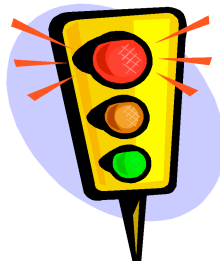

DID YOU KNOW...

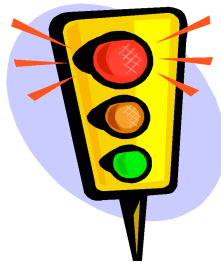
- Australia is the fourth highest income taxed country in the developed world.
- Every day we hear stories of Australians persecuted by the ATO
- We learn that 2000 Australian businesses are put into liquidation annually - not by banks but by the ATO.
- We hear of thousands of businesses forced to close down from the pressures of the GST and compliance difficulties caused by the rigours of BAS statements.
- The Howard Government does not have a mandate for the GST. This unfair tax passed through Parliament following a deal done with a dumped Democrats leader.
- Australians were prevented from discussing an alternative form of taxation - yet there is a solution, a simple tax that will raise twice as much as the current impositions which sees Australians as one of the highest taxed people in the developed world.

A one per cent tax on all withdrawals from financial institutions would raise about \$470 billion dollars annually - twice the amount of the current Federal tax system.

A one per cent debit tax would eliminate every other tax, including tax returns - ending the need for a 20,000-person ATO staff and the intimidatory tactics this Government department employs to enforce the current biased system.
